Ph.D. (Part-Time) with M.Phil.	Minimum 03 years & Maximum 05 years
Ph.D. (Part-Time) without M.Phil.	Minimum 04 years & Maximum 06 years

Note: No candidate shall submit the synopsis before the minimum period.

The candidate should submit the joining report along with a copy of the fee receipt to the Principal under a copy marked to the Registrar, S.V. University through the Head of the department on or after 28-10-2016 but not later than 09-11-2016. In case the guide is from a department other than the department where registered, the joining report is also to be forwarded by the Head of the department where the candidate is registered.

The exact topic of research is to be finalized within THREE months in case of Full-Time candidates and One year in case of Part-Time candidates as per the procedure given in the Regulations 2015. A separate order will be issued later by the principal after finalization of topic in the department concerned.

When the guide is from a department other than the department where registered, the candidate can use the facilities in the department of the guide and shall not demand for the facilities in the department where he/she is registered.

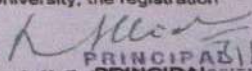
A full-time scholar shall not pursue any other full time course, or take up any occupation. Quarterly progress report and attendance from the department should be submitted to the Principal. If any Full-Time scholar is continuously absent for three months without permission from the guide and head of the department, his/her registration stands cancelled.

Every Ph.D. scholar should make a presentation of his/her research work in a seminar in the department regularly once in every Six months. Further, by the time of submission, the Research Scholar shall attend two Research seminars / Conferences of which one should be in other University.

The Ph.D. Research scholar shall appear for written examination in two papers. A Full-Time candidate has to take Ph.D. written examination 10-12 months from the date of registration, whereas a Part-Time candidate has to take Ph.D. written examination after two years from the date of registration.

A Full-Time candidate has to put in a minimum of 75% of attendance in each year until he/she submits his/her thesis. A Part-Time candidate has to put in a minimum of 30 days of attendance in each of the two consecutive years following the date of registration.

Note: If the candidate is a post graduate of other University, and if the PG degree is not recognized by S.V. University already, he/she has to submit his/her PG syllabus within one month of joining and get the degree recognized by S.V. University. If the degree is not recognized by S.V. University, the registration gets cancelled.
